BOARD OF DIRECTORS  
REGULAR MEETING**

**Minutes of July 9, 2015**

The meeting was called to Order by Board Chair Keith Lynn at 6:32 P. M.

1. Roll Call: Keith Lynn, Dennis Feeley, Larry Tuttle, Dale TenBroeck, Sherrill Boots and Chief Fuller were present.
2. Consent of Agenda: It was moved by Dennis Feeley and seconded by Dale TenBroeck that the Agenda be approved. The motion passed unanimously.
3. Oath of Office: Newly elected Director Sherrill Boots was sworn in as a Director of Evans Valley Fire District 6.
4. Approval of the Minutes of the June 11, 2015 Regular Board Meeting: It was moved by Dale TenBroeck and seconded by Sherrill Boots that the minutes of the June 11, 2015 Regular Board Meeting be approved. The motion passed unanimously.
5. Financial Reports by Jackie Smedegaard: June 9, 2015 to June 30, 2015 and July 1 to July 6, 2015. It was moved by Larry Tuttle and seconded by Dennis Feeley that the Financial Report for June 9, 2015 to June 30, 2015 be approved. The motion passed unanimously. It was moved by Dennis Feeley and seconded by Larry Tuttle that the financial report for July 1 to July 6, 2015 be approved. The motion passed unanimously.
6. Communications: Larry Tuttle reported on the July 8, 2015 ECSO Intergovernmental Council meeting:
  - A Strategic Planning session is being planned for September
  - The 2014 Annual Performance Report was presented. By the metrics used in the Report ECSO is doing a good job meeting its benchmarks for performance. However, it was noted that there continue to be problems, some of them significant, with dispatch for EVFD6 which are not addresses in the benchmarks. A lot of material was presented in the report and will be a subject of further discussion at future IGC meetings.

7. OLD BUSINESS:

Public Records & Public Meetings Policy: Chief Fuller asked that this be carried over until the August, 2015 Board meeting.

Resolution 15-03 to be corrected and approved: An error that had been noted in Resolution 15-03, Adopting the 2015-2016 Annual Budget. This error did not affect budget itself, just the way it was presented on the resolution. Dale TenBroeck moved to adopt the corrected Resolution 15-03. Sherrill Boots seconded the motion which passed unanimously.

Fire Station Siding/bid review: A single bid had been received by the bid deadline to submit proposals for work involving new siding on the main fire station. Chief Fuller had consulted with Luanne Richie of Special Districts Association of Oregon regarding whether the District could proceed on this project after receiving only one bid. Since the District had advertised an "invitation to bid" for two weeks in the River Press and the Chief had personally invited bids from three individuals, Luanne confirmed that the District had indeed complied with Oregon Public Contracting Law in soliciting bids.

The bid received by the deadline was from Tim McFadden, who was in attendance, in the amount of \$39,000. A second bid was received after the deadline, for \$40,990. Tim McFadden answered questions from the Board and provided details on various aspects of the project. Dale TenBroeck moved to accept the bid from Tim McFadden in the amount of \$39,000. Sherrill Boots seconded the motion which passed unanimously. Tim stated that work would begin in late September, after the Auxiliary's Annual Yard Sale.

8. NEW BUSINESS: (No New Business)

9. Chief's Report and Training Officer's Report (see attached): Chief Fuller presented the Chief's Report and Travis Crume presented his Training Officer's Report.

10. Good of the Order: Larry Tuttle suggested that attachments such as the Chief's Report and Training Report be included in the online version of the minutes; Web Master Bob Phillips said that he could do this. The signature cards need to be updated; Larry Tuttle will provide a letter to Umpqua Bank requesting changes; Sherrill Boots will handle it from there. Dale TenBroeck noted that the Auxiliary is in need of donations for the Yard Sale. Chief Fuller reported that Leona Bailey who lives past the West Fork on East Evans (and out of District) wants to be annexed and wishes to have the District pay for annexation expenses. Chief Fuller informed her that the District does not pay for annexation expenses.

11. Adjournment: Dennis Feeley moved that the meeting be adjourned. The meeting was adjourned at 7:51 PM.
